- Enhanced Export Competitiveness & Growth for SMEs: Provide support to SMEs to compete in international markets, expand their export capabilities, overcome barriers, and take advantage of opportunities in the global marketplace.

We are seeking to hire a Deputy Chief of Party (DCOP) to support the COP in case of a successful bid. The DCOP will be based in Colombo, Sri Lanka, and report to the A2F's US Office.

## **Primary Duties and Responsibilities:**

- Work closely with the COP to ensure that the design, implementation, monitoring and evaluation, and progress of all program activities are per established strategies and meet the program goals;
- Oversee planning, coordination, and day-to-day implementation of technical activities in partnership with technical team members and the COP;

- Provide strategic vision and technical expertise, and manage key technical staff, especially those focusing on areas such as climate-smart agriculture, renewable energy and improved enabling environment for agriculture;
- Ensure that cross-cutting themes such as sustainable resource management, renewable energy, and climate-smart agriculture are fully integrated into programming and activities;
- Evaluate and document project progress and lessons learned;
- Assume responsibility for quality control and timeliness of deliverables.

# **Key Qualifications:**

- Bachelor's degree in climate sciences, renewable energy, international development, or related field required, master's degree is preferred;
- Seven (7) years' relevant experience in any of these relevant fields: supporting private sector development, business enabling environment, export promotion, investment promotion, value chain development and SME development;
